Discussion

The OPM and Designer conducted a feasibility analysis of the facility and developed a schematic design including a proposed scope of work, schedule, and estimated budget. The District's Designer, Habeeb & Associates Architects, Inc., recommends window replacements at the Merrymount Elementary School, Wollaston Elementary School and the North Quincy High School. The Designer has confirmed that the windows will be in compliance with the MSBA's sustainability requirements.

MSBA staff reviewed the consultants' existing conditions analysis and proposed schedule provided by the District and have discussed the scope and budget with the District and its consultants. The District has provided a combined Total Project Budget of \$5,338,930 which includes a combined construction cost of \$4,359,380. Construction costs include:

- Merrymount Elementary School
 - \$99.43/sf for windows and demolition
 - \$278,216 for abatement and associated work
- Wollaston Elementary School
 - \$92.78/sf for windows and demolition
 - \$205,451 for abatement and associated work
- North Quincy High School
 - \$97.35 for windows and demolition
 - \$566,689 for abatement and associated work

MSBA staff recommends an estimated maximum Total Facilities Grant of \$3,510,514; however, the District may be eligible for up to an additional \$161,433 in grant funds, subject to the MSBA's review and audit of the District's owner's and construction contingency expenditures. Accordingly, staff recommends a maximum Total Facilities Grant of \$3,671,949 for the Project Funding Agreement for window replacement projects at the Merrymount Elementary School, the Wollaston Elementary School, and the North Quincy High School.
