

Berkshire Hills RSD: Monument Mountain Regional High School

Update on Project Scope and Budget Authorization

- MSBA Board approval on July 31, 2013.
- Local Authorization Votes on November 5, 2013.
- Project advancement contingent upon two successful ballot questions held on same day: Question One to approve borrowing of project funding, which requires a simple majority of the aggregate votes from the three member towns of Great Barrington, West Stockbridge and Stockbridge. Question Two to approve an exclusion from Proposition 2 ½ in each of the towns individually.
- Question One passed by simple majority, while the Town of Great Barrington did not vote to support Question Two, a Proposition 2 ½ Override.
- The School District seeks an extension of time to assess the nature and extent of the failed vote, and if community support is evident will conduct the votes again.

Staff supports an extension of an additional 245 days beyond the initial 120-day deadline in furtherance of the School District's efforts to secure support and funding for the proposed project.



Whitman-Hanson RSD: Project Update | Maquan Elementary School

Update on Project Scope and Budget Authorization

- MSBA Board approval on July 31, 2013.
- Local Authorization Votes on October 7, 2013.
- Project advancement was contingent upon two votes by the Town of Hanson at Town Meeting: the first vote to approve the project passed by a majority vote, while the second vote to fund the project did not pass as required by a two-thirds majority vote.
- The School District seeks an extension of time to conduct the votes. again with a Special Town Meeting scheduled for January 25, 2014, and a Special Election within 35 days from Special Town Meeting subject to the outcome of Special Town Meeting.

Staff supports an extension beyond the 120-day deadline to March 3, 2014 in furtherance of the School District's efforts to secure funding for the proposed project.






