RE: Accelerated Repair Program – Consultant Procurement 2021-2023 Update

In connection with its Accelerated Repair Program (the "Program"), the MSBA issued separate Requests for Designer and Project Management Services. The Request for Responses to Provide Designer Services was issued on March 10, 2021 and the Request for Responses to Provide Project Management Services was issued on February 24, 2021. The objective of the procurements was to select a pool of qualified Designers and Owner's Project Managers ("OPMs") that the MSBA will assign to districts that will be invited to participate in the Program beginning in 2021 through 2023.

On February 10, 2021, the MSBA, in conjunction with the Supplier Diversity Office ("SDO"), hosted a procurement overview meeting to share information about the Program and the associated procurements for designer and project management services.

Prior to the meeting, the SDO conducted outreach to hundreds of certified Minority- and Woman-Owned Business Enterprises ("MBE," "WBE," or "MBE/WBE") that provide design, project management, or related services to notify these businesses about the briefing. The MSBA posted notice of the meeting on its website. Representatives of 105 firms, including 49 SDO-certified firms, attended the meeting.

The MSBA received 44 applications in response to the Request for Responses for Designers (34 firms in total; 10 of those firms submitted two applications, one for roof and exterior windows/doors, and another for boilers) and 29 applications to the Request for Responses for Project Management Services. Of the 49 SDO-certified firms that attended the pre-proposal briefing, 14 submitted responses to provide designer services or project management services as the prime consultant. Other SDO-certified firms in attendance may have also applied as subconsultants.

The deadline for submission of a response to the Designer Services Request for Responses was April 7, 2021 and the deadline for submission of a response to the Project Management Services was March 24, 2021.
