RE: Summary of Approved Project Grants and Reconciliation to the Annual Program

Funding Cap

In accordance with the administrative procedures presented at the May 12, 2017 Board of Directors (the "Board") meeting, and later presented and approved at the August 29, 2018 Board meeting, this Memorandum summarizes all grants for projects approved by the Board in fiscal year 2024 ("FY24") and presents the annual reconciliation that compares approved grants subject to the annual program funding cap to the FY24 program funding cap.

Discussion

The MSBA statute places a limit on the estimated amount of grants that can be approved by the MSBA during a fiscal year. That annual estimated grant limit ("Grant Cap Space") is adjusted each year by an amount that is equal to the lesser of the rate of growth, by percentage, of dedicated sales tax revenues or 6.5 per cent¹. In May 2017, the MSBA implemented grant cap reconciliation procedures which enable the MSBA to annually reconcile Board approved projects to available Grant Cap Space, allocate project grants (whole or in part) to available Grant Cap Space in prior or future fiscal years, and capture Grant Cap Space associated with failed local votes, projects removed from the Capital Pipeline, or additional savings realized in the Final Audit Grant determination. Should the total value of approved projects in a given fiscal year be less than the available Grant Cap Space as determined at the close of the fiscal year, the MSBA captures the unallocated Grant Cap Space for future fiscal years.

Changing district schedules, variations in proposed project scope, and the timing of local approvals contribute to the challenge of predicting in which fiscal year a district will be ready for MSBA Board authorization. In addition to the variability of the timing for proposed projects, the estimated grant amount authorized by the Board can vary depending upon eligibility determinations, annual updates to a district's reimbursement rate, and a district's ability to secure local authorization and funding. The MSBA's administrative procedures provide a mechanism for reconciliation of the approved estimated grants and the available Grant Cap Space to maximize the amount of funds available to support school construction grants and minimize the impact of changing district schedules and scope, that vary from project to project.

¹ Commonwealth's FY 2024 Budget, SECTION 36. Chapter 70B of the General Laws is hereby amended by striking out section 7 and inserting in place thereof the following section: Section 7. There shall be a limit on the estimated amount of grants approved by the authority during a fiscal year. For fiscal year 2023, the limit shall be \$1,200,000,000; provided, however, that grant amounts relating to the authority's accelerated repair program shall not count against the limit set forth in this section. For each fiscal year thereafter, the limit shall be the limit for the previous fiscal year plus the lower of: (i) the rate of growth in the dedicated sales tax revenue amount as defined in subsection (a) of section 35BB of chapter 10; or (ii) 6.5 per cent.

As described in the Reconciliation of Approved Projects to the Annual Program Funding Cap dated October 18, 2023, Governor Healey signed the Commonwealth's FY24 Budget on August 9, 2023. As a result of Section 36, the following adjustments were made:

- Annual Grant Funding Cap Space for FY23 was reset to \$1,200,000,000, an increase of \$302,801,967 for FY23, compared to the previously determined \$897,198,033;
- Beginning in FY23, Accelerated Repair Program Approved Grants no longer counted against Grant Cap Space, which removed \$60,995,196 of allocated grants against the FY23 Grant Cap Space; and
- Beginning in FY24, the annual estimated grant limit will be adjusted by an amount that is equal to the lesser of the rate of growth, by percentage, of dedicated sales tax revenues or 6.5 per cent.

In accordance with the above procedures and adjustments, staff have completed the annual reconciliation for projects approved in FY24. Please note that, for all Core Program Project Scope and Budget Agreements approved in FY24, the Maximum Total Facilities Grant amounts were allocated in total to FY24 Grant Cap Space. Summaries of available Grant Cap Space and approved estimated grants funded within the limits of the Grant Cap Space are presented below:

² Annual Grant Funding Cap Space for FY24 is based on the rate of growth, by percentage, between the FY23 dedicated sales tax revenues of \$1,264,003,703 and the FY22 dedicated sales tax revenues of \$1,188,872,596, as reported by the Department of Revenue as of September 2023, resulting in a growth rate of 6.32 per cent.

In accordance with the Policy Recommendations for Administering Estimated Grants Memorandum presented at the May 12, 2017 Board meeting, implementation of MSBA Policy for Administering Estimated Grants Memorandum presented and approved at the August 29, 2018 Board meeting, and the Commonwealth's FY24 Budget, the \$1,009,268,928 of remaining Grant Cap Space for FY24 will be allocated to future fiscal years. The transfer of \$1,009,268,928 represents an increase of \$50,973,156 compared to the remaining Grant Cap Space of \$958,295,772 that was available at the conclusion of FY23.

As described in the Recommendation to Approve Supplemental Grants Memorandum dated October 18, 2023, the Commonwealth's FY24 Budget, along with the Board's Authorization of the MSBA's Executive Director to adjust the Maximum Total Facilities Grants for previously approved projects, has provided the resources and flexibility for the MSBA to further assist school districts partnering with the MSBA by increasing available Grant Cap Space, providing additional project grants, and allowing the MSBA to fund grants associated with the Accelerated Repair Program outside of the limits of the Grant Cap Space. A summary of approved grants funded outside the limits of the Grant Cap Space in FY24 are presented below:

On October 25, 2023, the MSBA Board of Directors authorized the Executive Director to adjust the Maximum Total Facilities Grants for Projects that received Project Scope and Budget Approval by the MSBA's Directors after October 1, 2022, and prior to October 1, 2023. The approval included authorization to increase Building Cost funding limits to \$516 per eligible square foot and to increase Sitework funding limits to \$52 per eligible square foot. The Total Board Authorized Maximum Total Facilities Grant does not reflect the increased Building Cost and Sitework funding limits. The increase to the Maximum Total Facilities Grant is accounted for in Attachment D, Supplemental Grants for Projects Approved for Project Scope and Budget between October 1, 2022 and October 1, 2023.
- 2. District submitted a Statement of Interest Removal Form. The District received Project Scope and Budget authorization (\$162,719,075 Total Board Authorized Maximum Total Facilities Grant) at the December 13, 2023 Board of Directors meeting. After deducting the previous Feasibility Study authorization (\$1,064,880) which followed invitation to Feasibility Study at the December 12, 2018 Board of Directors meeting, the Board Authorization Maximum Total Facilities Grant at Invitation to Project Scope and Budget was scheduled to be \$161,654,195.
